

**ROCK ISLAND COUNTY PROPOSITION**

**TO PAY FOR PUBLIC SAFETY COSTS SHALL ROCK ISLAND COUNTY BE AUTHORIZED TO IMPOSE AN INCREASE ON ITS SHARE OF LOCAL SALES TAXES BY ONE PERCENT (1.0%).**

**THIS WOULD MEAN THAT A CONSUMER WOULD PAY AN ADDITIONAL \$1.00 IN SALES TAX FOR EVERY \$100 OF TAXABLE RETAIL PURCHASES. IF IMPOSED, THE ADDITIONAL TAX WOULD NOT BE TERMINATED UNLESS BY A VOTE OF THE COUNTY BOARD.**

**COAL VALLEY FIRE PROTECTION DISTRICT PROPOSITIONS**
