PRESS RELEASE

In response to the increasing surge in the COVID 19 Pandemic, and reported high-usage of area hospital beds for COVID 19 positive cases; County Board Chairman Richard “Quijas” Brunk has issued the following order in the interest of the health and safety of the public and our employees:

- 1. Effective Wednesday, November 18, 2020 and until further notice, the County Office Building shall be closed to the public, subject to scheduled appointments.** Offices within the County Office Building will continue to operate on a limited basis, ensuring that necessary functions are carried out.
2. The Rock Island County Animal Care & Control Center, located at 4001 78th Avenue in Moline, will continue to operate, with COVID Protocols in place, including a limited number of persons allowed inside the facility at any one time. Wednesday Clinics will continue, with Parking Lot Check-In.
